STRIP CHIEF 2

DESCRIPTION

STRIPCHIEF-2 is a gel-type non-methylene chloride based, water clean-up stripper specifically designed for stripping varnish, enamels, acrylic paints.

STRIPCHIEF-2 is suitable for use on most paint systems including, Anti-foul, 2-pack epoxies, and 2-pack or moisturecure urethanes.

STRIPCHIEF-2 is also suitable for cleaning up brushes, and rollers.

STRIPCHIEF-2 contains selected ingredients to emulsify the stripped coating, allowing a water wash off.

Ideal for graffiti removal off masonry and timber surface.

STRIPCHIEF-2 is a low odour formula and is now considered hazardous (GHS- Global Harmonised System) however has low toxicity.

As before, normal good industrial practice should be adhered to i.e., use of gloves and eye protection as a very minimum.

Do NOT use in confined spaces.

STRIPCHIEF-2 has a longer "open time" than conventional solvent strippers, allowing for a deeper penetration to be achieved, facilitating full thickness coating.

Providing application thickness is ca 5mm STRIPCHIEF-2 will remain open and active for up to 24 hours.

SURFACE PREPARATION

Surface to be dry.

DIRECTIONS

Ensure the STRIPCHIEF-2 is well mixed; open can away from face.

Apply over the surface to be removed, using a brush (natural bristle not synthetic bristles).

Apply a coating at least 1-5 mm thick and allow to work.

When blistering is evident scrape or wash off with clean water.

Repeat if necessary if full thickness removal not achieved.

For difficult coating removal the use of several layers of newspaper placed on top of the applied stripper to trap the solvent on the surface longer, is effective.

COVERAGE

1-2m2/L

CLEAN UP

Water if still open and gel-like.

Do not allow to come in contact with mobile telephones, ABS or acrylic plastics.
